



# Occupations not on the Combined Lists of Eligible Skilled **Occupations**

## Skill Level 1 – 5 Occupations

January 2024

For occupations approved under the Pilbara DAMA but are not on the combined eligible list of skilled occupations, the following skills, qualifications, experience and employment background criteria will apply to any nomination for these occupations or any application for a TSS, SESR or ENS visa made under the Migration Legislation.

## Qualifications

Qualifications are to be assessed by the relevant Skills Assessing Authority (as specified in the Labour Agreement) as being at least equivalent to the relevant Australian Qualifications Framework (AQF) qualification detailed for the relevant tables below, in order to assist the Minister's decision as to whether the visa applicant has the necessary qualifications for the position.

## **Work Experience**

Work experience to fulfil visa requirements must be:

- Relevant to the nominated occupation and at the required skill level
- Full-time or part-time pro rata equivalent unless otherwise specified. Full-time work should be in accordance with the National Employment Standards; and
- Undertaken in the last five (5) years.

Where specified below, work experience to fulfil visa requirements, can be undertaken concurrently with work experience used to substitute qualifications, provided the work experience was at the same skilled level.

## ANZSCO Skill Level 1-3

For occupations included in the table below, the following skill and experience requirements apply. This visa applicant must:

Have undergone a skills assessment;

#### AND

 Meet the skill level as defined in ANZSCO, excluding where work experience can substitute formal qualifications;

#### AND

- Have at least one (1) year of relevant full-time work experience for the TSS visa program, where the relevant AQF qualification was undertaken in Australia; or
- Have at least two (2) years of relevant full-time work experience for the SESR visa program; or
- For the occupation of **Child Care Worker (skill level 3) ONLY**, have at least one (1) year of relevant full-time work experience for the SESR visa program;
- Meet the additional work experience required under the standard TSS or ENS programs.

 Meet the skill level as defined in ANZSCO, including where work experience can substitute formal qualifications\*;

#### AND

- Have at least one (1) year of relevant full-time work experience undertaken in Australia for the TSS visa program\*; OR
- Have at least two (2) years of relevant full-time work experience for the SESR visa program\*; or
- Meet the additional work experience required under the standard TSS or ENS programs.

<sup>\*</sup> This work experience can be undertaken concurrently with work experience used to substitute the formal qualifications.
